



## **BAY QUARTER SHORES, INC. Application For Use Of Club House Facilities**

*The following rules apply to organized groups of ten (10) or more individuals, one of which must be a member or associate member of Bay Quarter Shores.*

1. A \$50 DEPOSIT IS REQUIRED WITH THE RESERVATION. THE DEPOSIT WILL BE REFUNDED IF THE FACILITIES ARE LEFT IN THE SAME OR BETTER CONDITION. MANY USERS DONATE THEIR DEPOSIT TO BQS IN ORDER TO DEFAY COST.
2. THE \$50 DEPOSIT WILL BE RETAINED BY BQS UNLESS CHAIRS AND TABLES ARE RESTORED TO THEIR ORIGINAL POSITION, FLOORS ARE SWEEPED, THE KITCHEN IS CLEANED AND TRASH IS REMOVED FROM THE PREMISIS.
3. PICNIC AND CLUBHOUSE FACILITIES WILL NOT BE AVAILABLE TO ORGANIZED GROUPS DURING THE MONTHS OF JUNE, JULY AND AUGUST. POOL FACILITIES WILL NOT BE AVAILABLE TO ORGANIZED GROUPS AT ANY TIME.
4. NO PETS ARE ALLOWED IN THE CLUBHOUSE.
5. NO ALCOHLOIC BEVERAGES OTHER THAN BEER AND WINE ARE PERMITTED ON THE PREMISES.
6. ALL VEHICLES ARE TO BE PARKED IN THE DESIGNATED PARKING AREAS AND ARE NOT PERMITTED, EXCEPT FOR UNLOADING, IN THE CIRCULAR DRIVEWAY.
7. COMPLETED APPLICATION FOR USE OF CLUB HOUSE FACILITIES SHOULD BE SUBMITTED TO VP FOR ADMINISTRATION OR THE SECRETARY AT LEAST THIRTY (30) DAYS PRIOR TO ANTICIPATED USE.
8. IT IS THE RESPONSIBILITY OF THE PERSON OR PERSONS REQUESTING USE OF THE FACILITIES TO SEE THAT THE FACILITIES ARE LEFT IN AN ORDERLY MANNER, WITH TRASH IN THE PROPER RECEPTACLES, AND THE PREMISES AND CLUBHOUSE IN THE SAME CONDITION IN WHICH THEY WERE FOUND.
